- 5. In order to avoid late fee/interest, the cardholder can make the payment of the annual fee and the reversal will be adjusted when the reversal posting is made.
- 6. I hereby acknowledged the request made for Travel Quota information is correct. I declare and undertake that the overseas usage of card(s) shall be utilized strictly in accordance with the relevant exchange control regulations issued and as amended by the Bangladesh Bank from time to time. In the event I/my supplementary cardholder exceed my/our entitlements as per the exchange control guidelines, I undertake to bring the same immediately to the notice of AB Bank Limited, in writing. And in the event of any failure to comply with the prevailing exchange control guidelines issued by Bangladesh Bank, I shall be liable for action under the Foreign Exchange Regulations Act 1947 as amended, and be debarred from the Card facility. I understand that the card cannot be used via internet and any such attempt will make me liable for cancellation of the card by AB Bank Limited without any further notice. I also understand that the maximum international usage on my credit card will be limited up to the available credit limit (i.e. in local currency) on my credit card. I accept that AB Bank Limited reserves the right to accept or decline the application without giving any reason whatsoever. The undersigned will be liable for all charges incurred with the Supplementary Card(s) issued on the Account and each Supplementary Applicant will be liable for all charges incurred with the Supplementary jointly and severally with the holder of the Primary Card.
