## **SCOPE OF WORK**

The vendor shall supply and support **Red Hat Enterprise Linux Server, Standard Subscription** (3 Years), 28 Units (details in Annexure I).

## **Additional Requirements:**

• The local partner must demonstrate proven expertise in Red Hat Enterprise Linux deployments.

## **VENDOR REQUIREMENTS**

Only bidders meeting the following criteria are eligible to respond to this RFP:

- Must be a legally registered entity in Bangladesh.
- The bidder must be a regular taxpayer.
- Must submit a Manufacturer's Authorization Letter (MAF) from Red Hat or its authorized distributor.
- Must have prior experience in delivering and supporting similar solutions.
- Participating vendors must have at least 2 Red Hat Certified Engineers (RHCE).
- Any bidder who has been blacklisted or barred by any Government Department,
   Financial Institution, Bank, or Regulatory Body shall be disqualified. A Litigation
   Declaration Letter must be submitted.
