INTRODUCTION

We are seeking proposals for the supply and installation of 12V 120AH, VRLA (AGM) Batteries for our ABB UPS systems. The batteries are required to ensure Uninterrupted Power Supply (UPS) to our Datacenter, as the existing batteries have exceeded their lifespan and are no longer performing optimally.

SCOPE OF WORK

Supply of Batteries: 12V 120AH, VRLA (AGM) Batteries, Brand: Ultracell or Diamec or Leoch.

Quantity: 96 units.

Installation: Complete installation of batteries, including necessary accessories.

Testing & Commissioning: Ensure proper functionality post-installation.

COMMERCIAL REQUIREMENTS

Unit Price: To be quoted per battery. **Accessories:** To be included in the quote.

Installation Charges: To be included in the quote.

Total Cost: Including VAT & TAX.

VENDOR REQUIREMENTS

Only bidders meeting the following criteria are eligible to respond to this RFP:

- Must be a legally registered entity in Bangladesh.
- The bidder must have a valid trade license, VAT registration, and updated income tax certificate.
- Must have a minimum of 5 years prior experience in delivering and supporting similar solutions.
- Must have completed at least 2 similar projects in the last 3 years for reputed organizations (proof required).
- Must be an authorized distributor/ importer/ reseller of the proposed battery brand, or provide a valid authorization letter from the manufacturer.
- The proposed batteries must be original, brand-new, and imported directly from the manufacturer or authorized source. (BL must be submitted)
- Any bidder who has been blacklisted or barred by any Government Department, Financial Institution, Bank, or Regulatory Body shall be disqualified. A Litigation Declaration Letter must be submitted.
