VENDOR REQUIREMENTS

Only bidders meeting the following criteria are eligible to respond to this RFP:

- Must be a legally registered entity in Bangladesh.
- The bidder must be a regular taxpayer.
- Must submit a Manufacturer's Authorization Letter (MAF) from Oracle Corporation authorizing the vendor to submit the bid for the Renewal of ATS.
- Must have at least three (3) years of prior experience in providing Oracle support services to banks in Bangladesh.
- At least two (2) engineers with valid Oracle Certified Professional certification (preferably the Oracle Database 19c: Data Guard Administrator certification).
- Any bidder who has been blacklisted or barred by any Government Department, Financial Institution, Bank or Regulatory Body shall be disqualified. A Litigation Declaration Letter must be submitted.
