## INTRODUCTION

AB Bank PLC. invites qualified vendors to submit proposals for the Cisco SMARTnet contract for the year 2025. The selected vendor will be responsible for providing support for all installed cards/components and software licenses included in the contract as specified in this document. The Bank's decision regarding vendor selection will be final and binding.

### **SCOPE OF WORK**

Interested vendors are requested to collect the detailed product list from the Administration Department or by sending an email to <a href="mailto:rfp@abbl.com">rfp@abbl.com</a> with the subject line: "RFP for Cisco SMARTnet Renewal for 2025". The list includes chassis serial numbers. Vendors must ensure that all installed cards/component and software licenses must be included in the contract.

# **SERVICE LEVEL AGREEMENT (SLA) REQUIREMENTS**

The proposed service must adhere to the following minimum Service Level Agreement (SLA) terms. Bidders must explicitly confirm compliance with each point in their technical proposal.

- **Cisco TAC Support:** Vendors must ensure access to Cisco's Technical Assistance Center (TAC) providing 24x7x365 support for all covered devices.
- **Hardware Replacement:** The hardware replacement SLA must strictly match Cisco's current global policy for the specific service tier.
- **Software Updates:** The service must include access to all software updates, including major and minor releases, and critical security patches for all covered devices.
- **Escalation Matrix:** The vendor must provide a detailed escalation matrix. This must include local (Bangladesh) support contacts and a clear path for escalation to Cisco (OEM) support to ensure timely resolution of critical issues.

## **VENDOR REQUIREMENTS**

Only bidders meeting the following criteria are eligible to respond to this RFP:

- Must be a legally registered entity in Bangladesh.
- The bidder must be a regular taxpayer.
- Must submit a Manufacturer's Authorization Letter (MAF) from the OEM.
- Must have prior experience in delivering and supporting similar solutions.
- Any bidder who has been blacklisted or barred by any Government Department, Financial Institution, Bank, or Regulatory Body shall be disqualified. A Litigation Declaration Letter must be submitted.
