AB Bank PLC. invites qualified vendors to submit proposals for the supply and implementation of **Red Hat Enterprise Linux Server, Standard Subscription (3 Years), 30 Units**, including licenses, installation, and support services. The Bank's decision will be final.

SCOPE OF WORK

The vendor shall supply and support **Red Hat Enterprise Linux Server, Standard Subscription (3 Years), 30 Units** (details in **Annexure I**).

Additional Requirements:

- The local partner must demonstrate proven expertise in Red Hat Enterprise Linux deployments.

VENDOR REQUIREMENTS

Only bidders meeting the following criteria are eligible to respond to this RFP:

- Must be a legally registered entity in Bangladesh.
- The bidder must be a regular taxpayer.
- Must submit a Manufacturer's Authorization Letter (MAF) from Red Hat or its authorized distributor.
- Must have prior experience in delivering and supporting similar solutions.
- Participating vendors must have at least 2 Red Hat Certified Engineers (RHCE).
- Any bidder who has been blacklisted or barred by any Government Department, Financial Institution, Bank, or Regulatory Body shall be disqualified. A Litigation Declaration Letter must be submitted.
