# AB Bank PLC. and Its Subsidiaries

## Notes to the Financial Statements For the period ended 31 March 2026

### 1. Accounting Policies

Accounting policies have been followed in preparing these financial statements are same as applied in financial statements of the Bank of preceding financial year.

### 2. Revenue recognition

#### Interest income

The interest income is recognized on accrual basis. Interest on loans and advances ceases to be taken into income when such advances are classified or treated as Sub Standard (SS) as per BRPD circular no. 15 dated 27 November 2024 and is kept in interest suspense account. Interest on classified advances is accounted for as income when realized.

#### Investment income

Interest income on investments is recognized on accrual basis except treasury bills. Capital gains on investments in shares are also included in investment income. Capital gains are recognized when these are realized.

### 2.1 Provision:

#### i) Loans & Advances

Provisions for loans and advances has been made as per directives/instructions of Bangladesh Bank issued from time to time.

#### ii) Investments

Provisions for diminution in value of investment is made for loss arising on diminution value of investment in quoted shares and other investments have been accounted for as per Bangladesh Bank Guidelines/ instructions.

#### iii) Taxation

Provision for income tax has been made on taxable income after necessary adjustment made in accordance with the provisions of the Finance Act 2025, Income Tax act 2023 and other relevant rules as applicable.

### 2.2 Earnings Per Share (EPS)

Earnings Per Share (EPS) has been computed in accordance with International Accounting Standard (IAS)-33 by dividing the basic earnings by the number of ordinary shares outstanding as of March 31, 2026. According to IAS-33, EPS for the period ended March 31, 2025 was restated for the issues of bonus share in 2025. There is no convertible instrument of the Bank, thus no dilution effect has been considered.

### 2.3 Significant Deviation

#### I. Net Operating Cash Flow Per Share (NOCFPS)

Net Operating Cash Flow Per Share (NOCFPS) has been increased to BDT 4.96 from BDT (8.72) in 2026 compare to the same period of 2025. It is happened mainly due to the increase of both customer deposits and short term Borrowings (Liquidity support from Bangladesh Bank).

#### II. Net Interest income

Net Interest income is BDT (721.49) crore for the period of Janaury to March 2026. It is mainly due to increase of non-performing loans and significant increase of both deposit and borrowing interest rates.

### III. Increase of Income from Commission, exchange and brokerage

Income from Commission, exchange and brokerage has been Increased by BDT 4.70 crore in 2026 compare to the same period of last year. It is mainly due to the Increase of exchange gain of foreign currency and increase of commission income from both Letter of credit and Letter of guarantee.

### IV. Decrease of Earnings Per Share (EPS)

Earnings Per Share (EPS) has been decreased to Tk. (8.86) from Tk. (2.90) compare to same reporting period of last year. This is happened due to mainly decrease of net interest income. Net interest income has been decrease by BDT 549.55 crore in this reporting period compare to the same period of last year.
